PILATUS AIRCRAFT LTD. - PC-12 and PC-12/45 FUEL TANK INWARD VENT VALVES - Replacement

Applicability

PILATUS AIRCRAFT LTD. - Model PC-12 and PC12/45 airplanes, Manufacturers Serial Numbers: MSN 101 up to and including MSN 186.

Reason

This Airworthiness Directive (AD) is prompted by a report of abnormal automatic engagement of the fuel booster pumps during normal aircraft operation of a PC-12 airplane.

Investigations revealed that under certain conditions the fuel tank inward vent valves may fail in the closed position. Moisture ingestion, followed by cold soak can lead to freezing of the fuel tank inward vent valve; resulting in an increase in the cracking pressure.

This condition, if not corrected, could lead to airfoil distortion and potential structural damage due to deformation of the integral fuel tank surface, caused by exessive pressure differentials between the fuel tank and the outside atmosphere.

In order to correct the condition described this AD requires removal of the existing fuel tank inward vent valves and installation of modified vent valves.

Compliance:

Within the next 10 hours time-in-service (TIS) after the effective date of this AD, unless accomplished previously.

The actions required by this AD shall be done in accordance with the Accomplishment Instructions of PILATUS PC-12 Service Bulletin No.: 28-003 Rev.1, dated September 30, 1997.
