- (1) Model PC-12 and PC-12/45 airplanes from Manufacturers Serial Numbers (MSN) 321 up to and including MSN 331, MSN 333, MSN 335, MSN 336, MSN 338 up to and including MSN 341, MSN 343 and MSN 345.
- (2) Model PC-12 and PC-12/45 airplanes in which Service Bulletin PILATUS PC-12 Service Bulletin No. 27-008 has been incorporated using Flap Control and Warning Units (FCWU's) Manufacturers Part No. FCWU99-3 which have Serial Numbers (S/N) 100,000 or less.

EFFECTIVE DATE: November 09, 2000.

REASON:

During routine quality assurance inspections the component manufacturer has identified production quality deficiencies in the Flap Control and Warning Units (FCWU's) Manufacturers Part No. FCWU99-3 Serial Numbers (S/N) 100,000 or less. A potential fault in the FCWU software could inhibit detection of flap twist after a mechanical failure scenario.

In order to correct the condition described this Airworthiness Directive (AD) requires replacement of certain Flap Control and Warning Units.

COMPLIANCE: (Required as indicated, unless already accomplished)

To prevent failure of the Flap Control and Warning Unit as a consequence of a potential fault in the FCWU software, accomplish the following:

(a) Not later than one calendar month after the effective date of this Airworthiness Directive;

(1) Remove Flap Control and Warning Unit (FCWU) Manufacturers Part No. FCWU99-3 which has S/N 100,000 or less and install FCWU with S/N 100,001 and subsequent as specified in and in accordance with the Accomplishment Instructions of PILATUS PC-12 Service Bulletin No. 27-012, dated September 13, 2000 or later revisions approved by the Swiss Federal Office for Civil Aviation (FOCA).

(b) Spare Parts:

(1) As of the effective date of this AD, no person shall install any Flap Control and Warning Unit, Manufacturers Part No. FCWU99-3, which has S/N 100,000 or less, on any Model PILATUS PC-12 Series airplane.
