- All PC-12 and PC-12/45 airplanes from Manufacturer Serial Numbers MSN 101 up to and including MSN 365 with rear bench seats (PIL P/N 525.22.12.016) installed.
- (2) All bench seats (PIL P/N 525.22.12.016) held as spare.

EFFECTIVE DATE: December 28, 2000.

REASON:

During design rewiev it has been found that the flow of oxygen to each occupant on the rear bench seat is reduced through two metered connectors when only one reduction of flow is necessary. This could result in insufficient oxygen quantity available to the occupants of the rear bench seat in some emergency conditions. In order to correct the condition described this Airworthiness Directive (AD) requires replacement of the metered connector and oxygen tubing in the rear bench seat to give an unrestricted flow of oxygen to the outlet manifold.

COMPLIANCE: (Required as indicated, unless already accomplished)

To prevent failure of the oxygen system to deliver oxygen to the rear bench seat in the event of some emergency conditions, accomplish the following:

(a) Required within the next 30 days after the effective date of this Airworthiness Directive;

(1) Replace the metered connector and oxygen tubing (together with the related components) in the rear bench seat as specified in and in accordance with the Accomplishment Instructions of PILATUS PC-12 Service Bulletin No. 35-002, dated December 19, 2000 or later revisions approved by the Swiss Federal Office for Civil Aviation (FOCA).

(b) Spare Parts:

(1) As of the effective date of this AD, no person shall install any rear bench seats (PIL P/N 525.22.12.016), on any Model PILATUS PC-12 Series airplane, unless the metered connector and oxygen tubing has been replaced in accordance with PILATUS PC-12 Service Bulletin No. 35-002, dated December 19, 2000 or later revisions approved by the Swiss Federal Office for Civil Aviation (FOCA).
