REASON:

It has been found on some PC-12 and PC-12/45 airplanes that:

- (a) the forward and aft facing passenger seats identification tags incorrectly identify the Pilatus part number although the ERDA Vendor Part Number is correct.
- (b) the forward pedestal legs have been improperly assembled. Seats with the legs installed in reverse order do not meet conformity requirements and may not perform as intended under emergency landing conditions.

In order to correct the condition described this Airworthiness Directive (AD) requires inspection of the applicable seats and corrective actions to configure the seats correctly, if necessary.

COMPLIANCE:

Required as indicated below, unless already accomplished:

Not later than 31 December 2002;

(a) PASSENGER SEAT IDENTIFICATION - PART NUMBERING

On all passenger seats, with part numbers as specified in the applicability section Part A of this AD; Locate the identification tag and crosscheck the ERDA part number with the Pilatus part number. If the part numbers do not match; affix new tag reflecting the proper Pilatus part numbers.

(b) SEAT FORWARD LEG INSPECTION

On all passenger seats, with part numbers and serial numbers as specified in the applicability section Part B of this AD; Inspect forward pedestal legs for correct installation. If legs found to be installed in reverse order; perform corrective actions to configure the seats correctly.
