FUEL - DISTRIBUTION ENGINE DRIVEN PUMP - REPLACEMENT RELIEF-VALVE-BODY HOUSING AND SEALS

1. Planning Information

A. Effectivity

All PC-9 aircraft from MSN 001 and MSN 002, MSN 101 thru MSN 171, MSN 173 thru MSN 178, MSN 180 thru MSN 247 and MSN 501 thru MSN 567, with Engine Driven Pump (EDP) Vendor Part Number RG9570R1, PILATUS Part Number 968.84.51.106 or Vendor Part Number RG9570R, PILATUS Part Number 968.84.51.104 installed.

All EDP Vendor Part Number RG9570R1, PILATUS Part Number 968.84.51.106 and Vendor Part Number RG9570R, PILATUS Part Number 968.84.51.104 held as spare.

B. Concurrent Requirements

None.

C. Reason

(1) Problem

Fuel leakage through the Engine Driven Pump (EDP) relief valve.

(2) Cause

Fuel leakage is possible past the gasket of the EDP relief valve because the gasket can be pushed out between the relief valve housing and the EDP housing.

(3) Solution

This Service Bulletin changes the diaphragm and/or valve housing assembly of the EDP (Lear Romec SB RG9570-73-006 or SB RG9570-73-002). The new design of valve housing and seals gives better protection against fuel leakage.

This Service Bulletin gives the data and instructions to:

- Remove the EDP
- Do Lear Romec SB RG9570-73-002 (for EDP Vendor Part Number RG9570R1, PILATUS Part Number 968.84.51.106)
- Do Lear Romec SB RG9570-73-006 (for EDP Vendor Part Number RG9570R, PILATUS Part Number 968.84.51.104)
- Install the EDP

Post Vendor SB RG9570-73-002 or SB RG9570-73-006 the EDP becomes PILATUS P/N: 968.84.51.108 and Vendor P/N: 9570R1/M.

3. Accomplishment Instructions - Aircraft

A. Preparation

(1) Remove the EDP (Ref. AMM, 28-20-10, Page Block 401).

B. Modification of the EDP

Lear Romec SB RG9570-73-002 and SB RG9570-73-006 must be done at PILATUS or at an approved repair station. The repair station must be certified by the Regulatory Agency to do fuel accessory repairs and modifications.

(1) Do Lear Romec SB RG9570-73-002 or SB RG9570-73-006 as applicable on the removed EDP.

C. Close up

- Install the modified EDP (post Vendor SB RG9570-73-002 or SB RG9570-73-006) (Ref. AMM, 28-20-10, Page Block 401).
- (2) Remove all tools and materials. Make sure the work areas are clean.

D. Documentation

(1) Make an entry in the Aircraft Logbook that this Service Bulletin has been incorporated.

4. Accomplishment Instructions - Spares

A. Modification of the EDP

Lear Romec SB RG9570-73-002 and SB RG9570-73-006 must be done at PILATUS or at an approved repair station. The repair station must be certified by the Regulatory Agency to do fuel accessory repairs and modifications.

(1) Do Lear Romec SB RG9570-73-002 or SB RG9570-73-006 as applicable.

B. Documentation

(1) Make an entry in the spare parts inventory list that this modification has been carried out.
